Subject: Implementation of the Office order No. 2 dtd. 10.8.2001, regarding extension in power load upto 25% of the sanctioned load for the purposes of expansion/Modernization.

It is intimated that all the Regional Offices of the Board are implementing the subject cited office order in its own manner / style, which created problem.

Keeping in view, the Board has decided that all Regional Offices in respect of implementation of subject cited office order will ask the industry to file the application for one time clearance for expansion in power load upto 25% of sanctioned load alongwith an affidavit & to complete all the six conditions laid in the said office order. The Competent Authority (as the case may be) will issue clearance certificate. It is made clear that in case of any deviation from the above, it will be the sole responsibility of the concerned regional office / official. The sample performa of clearance certificate is on the reverse of this letter.
