**OFFICE ORDER**

In partial modification of the Board notification No. Admn./SA-2/F.No.178/98/1 Dated 20.1.1998, Punjab Pollution Control Board in its 107<sup>th</sup> meeting

held on 7.7.2000 had decided that the cases of the industries for grant of "Consent to establish"/"Consent to Operate" in non-designated areas of the State shall be decided as per the following policy:

1. No new industry of any category shall be allowed in the approved residential area of any town of the State of Punjab. The approved residential area shall be designated either by PUDA, Municipal corporation/Improvement Trust or any other designated authority of the State and it should be duly reflected in the Master Plan.
2. No red category industry shall be given consent to establish within the municipal limits except in the designated industrial area of the State.
3. The Board may continue to grant "Consent to establish" to green category of industries which are proposed to be located in mixed category areas or predominantly industrial areas within the municipal limit of a Town/City after classification of the area by CTP/STP/DTP.
4. The Board may grant "Consent to Operate" to the entire existing green category of industries in mixed category areas or predominantly industrial areas.
5. The Board may grant "Consent to Operate" to old red category of industries operating in approved residential areas or mixed areas but required to be shifted, if they have installed adequate Effluent Treatment Plants and Air Pollution Control Devices.
  - i) Initial "Consent to Operate" shall be for a period of one year with the condition that it will shift to the designated industrial area within stipulated period.
  - ii) The Board may further extend this period on merit after the expiry of one year in the rarest of the cases subject to the approval of the Board of Directors.

Accordingly, Board Order No. GPC/1999-2000/Gen-434/F-1, Dated 16.8.2000 was issued to notify the above said decision of the Board.

This issue was again considered by the Board in its 108<sup>th</sup> meeting held on 29.9.2000 and the Board decided to replace clause No. 2 of the above said Board Order as under:

No red category of industries shall be given "Consent to establish" within area of Municipal Corporation/Committee limits except in the designated industrial areas declared by the CTP/STP/DTP and also in the areas classified by Department of Industries and Commerce through press note or circular issued by them from time to time besides the Areas/industries exempted by the Government, while acquiring land for such purposes.

The Board in its 109<sup>th</sup> meeting held on 25.1.2001 further decided that the clause No. 5 of the Board Order Dated 16.8.2000 regarding grant of "Consent to establish"/"Consent to Operate" to the industries situated in the non-designated areas of the State will be restricted only to 5 cities namely Ludhiana, Jalandhar, Amritsar, Batala and Mandi Gobindgarh.

The Board Order No. GPC/1999-2000/Gen-434/F-1 Dated 16.8.2000 stands partially amended as per the decisions taken by the Board in its 108<sup>th</sup> meeting held on 29.9.2000 and 109<sup>th</sup> meeting held on 25.1.2001 as per above,


