OFFICE ORDER

It has been decided to delegate power to Senior Environmental Engineer's, Zonal Offices, to grant consent to establish / operate to common effluent treatment plant, where common effluent treatment plant are installed / in use exclusively for the small scale industries. Senior Environmental Engineer, Zonal Office, shall grant consent to such Common effluent treatment plant's after ensuring that the treated trade effluent discharge conforms to the standards prescribed by the Board for such nature of discharges. After the grant of the consent, Zonal Office will be required to send a copy of the consent granted to respective branch in the Head Office dealing with the subject matter of Common Effluent Treatment Plant.

2. Power to grant consent to common effluent treatment plant's other than exclusively for small scale industries will remain with Chairman of the Board, however, Zonal Offices / Regional Offices shall intimate the complete consent status and pollution control arrangements provided by each industrial unit discharging effluents in the common effluent treatment plant's with clear-cut recommendations in the matter, while sending consent cases of common effluent treatment plant to Head Office.

These orders will be applicable with immediate effect.
