OFFICE ORDER

Sub: Review of the validity period of consent to operate granted by the Board under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

The Board in its 123rd meeting held on 6/9/2004 considered the subject cited matter and reviewed the rate of consent fee to be charged and validity period of consent granted by the Board under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981. The Board decided that onward the validity period of grant of consent and the rate of consent fee to be charged from the industries under the said Acts, in the state of Punjab will be as per the following policy :-

Sr. No.	Particulars	Maximum validity period
1.	First time after obtaining consent to establish irrespective of category of units	One year
2.	All large and medium scale industries	Five years
3.	Small scale industries (Red Categories)	Five years
4.	Small scale industries (Green Categories)	15 years
5.	Units with ISO-14000 certificate irrespective of category (Not for fresh cases)	One year over and above the period specified at Sr. No. 2 & 3

2. Rate of consent fee to be charged from the industries at Sr. No.2 & 3 for grant of consent under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and Water (Prevention & Control of Pollution) Act, 1974 will be as per Annexure 'A' attached herewith.

3. Rate of consent fee to be charged from the industries at Sr. No.4 for grant of consent under the provisions of Air (Prevention & Control of Pollution) Act, 1981 and Water (Prevention & Control of Pollution) Act, 1974 will be as per Annexure 'A' attached herewith. However, the Board shall continue to charge application fee from the industries falling under green category @ 50% of the consent fee to be charged for 15 years.

4. Consent to the industries may be granted, even for lesser period specified above, where the industry apply for consent to operate for lesser period due to poor financial position or industry is taken on lease for a limited period or due to administrative reasons for implementation of the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

5. Separate consent fee will continue to be charged under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

These orders only supercedes the orders / circulars issued pertaining to validity period of consent granted and the rate of consent fee charged from the industries under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

These orders will be applicable with effect from 01/10/2004.
