The provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 made it mandatory that each industrial unit should establish/operate with consent to establish/operate from the State Board under these Acts. Accordingly, under the provisions of section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and section 21 of the Air (Prevention & Control of Pollution) Act, 1981, each industrial plant gets itself registered, in terms of consent, with the Board. New industrial plants are commissioned after obtaining consent to establish and clearance certificate from the Board for release of electric connection by Punjab State Electricity Board. But, some times due to dispute between the Partners/Directors of the firms or some other fenson, said as mancial loss or bankruptcy, the firms are closed by owners of these industries without surrendering the electric connection. The owners of such industries sometime inform the Board about closing of their unit. Accordingly, the Board closes the files of such industries maintained under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986. But, it has been observed by the Board that with the passage of time, these industries are sold or leased to new owners, which start process/ operation in such premises of highly polluting in nature. The owners/lessee of these firms never apply to the Board for consent to establish/operate as required under the provisions of said Acts and continue to cause environmental pollution without taking any preventive measures.

The matter was placed before the Board in its 135th meeting held on 31/5/2007 and it was decided by the Board that in future, whenever any industry is

closed on its own, its electric connection must be got disconnected from Punjab State Electricity Board so that it could not be restarted without the NOC/clearance of the Board. The PSEB will restore the electric connection on production of NOC/consent obtained from Board by the operator of new unit.
