Subject: - Policy to be adopted for installation of sewage treatment plant for Hotels/Restaurants/Marriage Palaces/Resorts in operation and proposed to establish/ being established.

In continuation to Board's letter no. EE (EPA)/2003/3987-4008 dated 5/11/2003, considering the installation of sewage treatment plants of certain cities/towns, it has been decided to adopt following policy for installation of sewage treatment plant for Hotels/Restaurants/Marriage Palaces/Resorts in operation/ proposed to establish/ being established and having disposal of domestic effluent into sewer leading to sewage treatment plant of the town/city:-

- The existing member units shall provide oil and grease trap & septic tank (as primary treatment plant) before discharging effluent to local body's sewer leading to STP of town/city, individually.
- The member units which are outside Municipal limit/not connected to the sewerage system leading to STP/where adequate surplus capacity in existing STP is not available, shall provide its own sewage treatment plant.
- All the member units shall submit NOC/Acceptance certificate of local body regarding discharge of effluent into sewer leading to STP and adequacy of STP to take pollution load of the unit.
- All the member units shall be responsible for working of sewer lines within his area and shall be specifically banned to dispose off solid waste through sewer and shall dispose of solid waste in environment friendly manner.
- All the member units shall get 'consent to operate' of the Board under the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 and will comply with all the provisions of the said acts.
