1. Some officers have challenged the seniority list of Asstt. Env. Engineers determined by the Board vide letter No.20056-125 dated 29/12/1997 by filing CWPs in the Hon'ble Punjab and Haryana High Court. As such the seniority will be subject to the decision in CWP No. 6003 of 1999 and 2093 of 1998.

The Secretary to Govt. of Punjab, Department of Science, Technology & Environment has determined the seniority of Sh.Sandeep Behl by an order dated 26/06/2015 issued vide No. 3/34/2014/STE(5)/548899/4 dated 27/7/2015 by deciding his representation given in compliance of an order dated 28/1/2015 of the Hon'ble Punjab & Haryana High court in CWP No. 160 of 1997 and CWP No. 898 of 2013. Sh Harbir Singh has challenged the said order of the Secretary to Govt. of Punjab, Department of Science, Technology & Environment, Chandigarh by filing CWP No. 18054 of 2015 before the Hon'ble Punjab & Haryana High Court. The Hon'ble Punjab and Haryana High Court by an order dated 28/8/2015 has directed to maintain Status quo in the case with regard to the seniority. The Seniority of Sh. Sandeep Behl has been determined in accordance with office order No. 704 dated 17/8/2015 passed by the Punjab Pollution Control Board in pursuance to orders dated 26/06/2015 of the Secretary to Government of Punjab, Deptt. of Science, Technology and Environment issued on 27/07/2015. However, seniority of these officers will be subject to the decision of the Hon'ble Punjab & Haryana High Court in CWP No. 18054 of 2015.
